The New Area Code Is Coming to the South Carolina 864 Area Code Region

To ensure a continuing supply of telephone numbers, the Public Service Commission of South Carolina approved the addition of the new 821 area code to the geographic region served by the 864 area code.

What is an area code overlay?

An overlay is the addition of another area code (821) to the same geographic region as an existing area code (864). An overlay does not require customers to change their existing area code but does require using a new dialing procedure to complete calls.

Who will be affected?

The new 821 area code will serve the same geographic area currently served by the existing 864 area code. The 864 NPA covers the northern portion of the state and serves the larger cities of Greenville, Spartanburg, Anderson, and many other smaller communities.

What will be the new dialing procedure?

All calls in the 864 area code that are currently dialed with seven digits will need to be dialed using area code + telephone number. The same 10 -digit dialing procedure will apply to telephone numbers that are assigned in the new 821 area code.

When will the change begin?

Effective **January 19, 2024**, you should begin dialing the area code + telephone number whenever you place a call. If you forget and dial just seven digits, your call will still be completed.

Beginning **July 19, 2024**, you must dial the area code + telephone number on all calls, including calls within the 864 area code. On and after this date, if you do not dial the area code + telephone number, your calls will not complete and a recording will instruct you to hang up and dial again, including the area code.

Beginning **August 19, 2024**, new telephone lines or services may be assigned numbers with the new 821 area code. If you have a number in the new 821 area code, you must dial the area code + telephone number or the call will not complete.

What will you need to do?

In addition to dialing the area code + telephone number for local calls, all services, automatic dialing equipment, or other equipment that is programmed to dial a 7-digit number will need to be updated to include the area code. Examples are life safety systems, medical monitoring devices, fire or security alarms, PBXs, fax machines, Internet dial-up numbers, speed dialers, call forwarding settings, voicemail services and similar functions. You should update your websites, personal and business stationery and checks, advertising materials, personal and pet ID tags and other such items to ensure the area code is included.

What will remain the same?

- Your telephone number, including current area code, will not change.
- The price of a call, coverage area, or other rates and services will not change due to the overlay.
- What is a local call now will remain a local call regardless of the number of digits dialed.
- You can still dial three digits to reach 911 and 988, as well as 211, 311, 411, 511, 611, 711 or 811.
