Terms of Service

- When you opt-in to receive specific types of operational, billing or marketing messages from Frontier (each type a "Program"), you agree to these Mobile Terms and Conditions and to Frontier's Privacy Policy and Terms of Use.
- 2. One way to Opt-in is to text "Learn" to 37687 (FRNTR) to "stay up to speed with the latest deals, offers, and ForMe Frontier Rewards". We will send you a message to confirm your signup to a Program. Message and data rates may apply. Message frequency varies. Text "HELP" for help. Text "STOP" to cancel.
- 3. Another way to Opt-in is to sign up for new service on Frontier.com and to check the Opt-in for Marketing SMS Option @ <u>https://frontier.com/buy/contact-credit</u>. Finally you can sign up with a Frontier Sales or Care rep by asking to be opted in for Marketing SMS.
